



Lucky Lucca's Stud Service Contract

This agreement (“**Agreement**”), dated as of _____, 20__ (the “**Effective Date**”), is between _Edith Wachter _____, the stud dog owner (“**Stud Dog Owner**”),

and _____ the bitch owner (“**Bitch Owner**”). The subject of this Agreement is the breeding (“**Breeding**”) of the bitch (“**Bitch**”) and stud dog (“**Stud Dog**”) listed below.

1. Compensation.

- a. Bitch Owner agrees to pay Stud Dog Owner (a) a non-refundable stud service fee (“**Stud Fee**”) of \$1500 for stud services performed by the Stud Dog. All payments due under this Agreement shall be made in US Dollars via payments through Zelle or cash at time of breeding.

- b. If 2nd insemination is requested, the price will be determined at the time of contract signing between the parties.
 - c. **A non-refundable** deposit of \$250 is required to reserve availability of Stud Dog. This \$250 goes toward the total stud fee.
- 2. **Stud Fee Puppies.** Stud Dog Owner relinquishes any right to puppies from the planned litter.
- 3. **Breeding & Litter**
 - a. Breeding. This breeding will be with fresh, chilled semen via artificial insemination (aka side by side artificial insemination AI)
 - b. Repeat Breedings. Stud Dog Owner provided that if no puppies result from the Breeding, Stud Dog Owner agrees to provide **one** repeat breeding to the same Bitch for a stud service fee of \$_____.
 - c. Breeding Expenses.
 - i. Bitch Owner agrees to pay all expenses incurred for the purpose of the Breeding at the time in which they are incurred, including veterinary costs, and artificial insemination costs, and shipping costs.



- ii. Semen collection and evaluation costs for this breeding will be paid by Bitch Owner
 - iii. Semen shipping costs for this breeding will be paid by Bitch Owner.
 - e. Vaccinations and Exams. Bitch Owner agrees to accept full responsibility to ensure that all offspring resulting from the Breeding be treated for parasites and receive the age-appropriate vaccines as recommended by the Bitch Owner's veterinarian of choice.
4. **Bitch Owner Obligations.** Bitch Owner represents, warrants, and agrees as follows:
- a. Bitch. The Bitch is healthy, of sound and stable temperament, is of breeding quality, disease and parasite-free.
 - b. Documentation. To provide Stud Dog Owner (i) a negative Brucellosis test within **14 days** of the Breeding.
 - c. Notification. To notify Stud Dog Owner, in writing (by email or text), of the birth and number of puppies within a week of the Breeding. To send photographs of the litter.
 - d. Accidental Breedings. To keep the Bitch properly confined following the Breeding for the duration of her heat cycle to ensure there are no accidental breedings. If such accidental breeding does occur, Bitch Owner agrees to notify Stud Dog Owner within 24 hours.
5. **Stud Dog Owner Obligations.** Stud Dog Owner represents, warrants, and agrees as follows:
- a. Stud Dog. The Stud Dog is healthy, of sound and stable temperament, is of breeding quality, is parasite and disease-free.
 - b. Stud Dog Documentation . To provide Bitch Owner (i.) a negative Brucellosis test within 14 days of the Breeding (ii) documentation of current health clearances prior to Breeding (if applicable).



6. **Confidentiality of Disputes.** Bitch Owner and Stud Dog Owner agree, that in the event of a dispute between them, neither will publish or communicate the existence or content of such dispute in any media or forum, including social media, provided that this provision shall not prevent either party from bringing legal action or engaging in confidential mediation.
7. **Agreement to Mediate.** If a dispute arises out of or relates to this Agreement, or the alleged breach thereof, and if the dispute is not settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation before resorting to arbitration, litigation, or some other dispute resolution procedure. The process shall be confidential based on terms acceptable to the mediator and/or mediation service provider.
8. **Governing Law.** This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by and construed in accordance with the laws of the State of Florida without regard to the conflicts of law provisions thereof.
9. **Miscellaneous.** This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous agreements, negotiations, discussions, and understandings, written or oral, between the parties with respect to such subject matter. Neither party may assign, transfer, or subcontract any obligations (or rights) under this Agreement without the prior written consent of the other party. No changes, modifications or waivers to this Agreement will be effective unless in writing and signed by both parties. In the event that any provision of this Agreement is determined to be illegal or unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. This Agreement may be executed in any number of counterparts and such counterparts together shall constitute the same instrument. This Agreement may be executed by electronic signature, which shall be considered as an original.
